We are excited to welcome you to Grants Pass Downs' 2020 Spring and Summer meets! The first successful commercial meet in Grants Pass last fall was only possible because of you. Thank you for investing in the future of Oregon Racing, we are looking forward to making this year's opportunities a success!

Grants Pass Downs has made significant improvements at the race track; we have widened the track for 10-horse fields, implemented 1500 tons of sand, added new equipment, new mile markers, a starting gate, and a state-of-the-art equine ambulance. We have added security improvements, with around the clock security officers for our participants' safety. We will be checking in and out all who access the backside, so please remember to present your Oregon Racing Commission License.

The purses are very healthy, thanks to Mr. Boersma's guaranteed commitment of \$60,000 per race day! There are 19 race days for spring and summer with the opening weekend on May 10 and final day on July 12. We are also hosting the AQHA regional Adequan Challenge with a total purse of \$35,000. Trials will be held on June 20 with finals on July 12.

We are also pleased to announce that Randy Evers, former Executive Director of the Oregon HBPA has joined us as our new president; he and our leadership team welcome you to another season. We will be hosting a commencement dinner at 6pm on Friday, May 8, at Grants Pass Downs and look forward to seeing you there!

STALL APPLICATION

Stalls will be assigned upon completion and filing of application. Stalls not occupied within 48hrs of the entry date are reassignable. Stalls and stable areas must be kept clean and hoses must have a shut off device. Straw, pellets or shavings may be used for bedding.

COGGINS

All horses, including pony horses, are required to have proof of a negative Coggins tested within the last six months prior to entering. See ORC regulations here:

RULES, REGULATIONS AND TERMS OF USE FOR GRANTS PASS DOWNS, JOSEPHINE COUNTY FAIRGROUNDS AND RV PARK

SECURITY

All visitors and horsemen will be required to enter the barn area through a secured entrance. They will be expected to present a valid ORC license. All horsemen must hold a valid ORC license and visitors must be accompanied by a licensee and checked in at a security checkpoint before entry. All persons entering the barn area consent to search by security personnel. All persons entering the barn area agree to abide by local statute, and ORC rules and regulations.

VEHICLES

Please observe and obey speed limits while driving on the backstretch. Barn access is not permitted during training hours while the track is open. (Except Vets & Farriers)

DOGS

Dogs must always be kept on a leash and under control. You are responsible for cleaning up after your dog.

TRASH

Dumpsters are emptied weekly; you are responsible for emptying your trashes into the dumpsters on a weekly basis.

MANURE

Please place all bedding and manure into designated bins that will be emptied daily. Bins are only for the disposal of manure or bedding; *no hay strings or trash may be disposed in manure bins.*

REQUIRED DOCUMENTATION

Must be complete and accurate with horses approved, current coggins and W-9 for every owner and or trainer of record. Please turn all documents in to the Grants Pass Downs Racing Office.

IMPORTANT NOTICE

All horses are required to have a negative Coggins test

Stalls shall be kept clean during the meet and cleaned and stripped before departure. A fee of \$25.00 per stall will be charged to the Trainer of record for each allocated stall that is not cleaned and stripped. Straw, pellets or shavings may be used. Please do not drive in the barn areas during training 7-10AM and during Race Days.

Track is closed every Tuesdays.
